2. HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW

DANGER. CORROSIVE. CAUSES IRREVERSIBLE EYE DAMAGE. CAUSES EYE AND SKIN BURNS. MAY BE FATAL IF ABSORBED THROUGH SKIN. HARMFUL OR FATAL IF SWALLOWED.

Principal routes of exposure: Eye contact. Skin contact. Inhalation. Ingestion.

Eye contact: Corrosive. Causes irreversible eye damage. Causes permanent eye damage, including blindness.

Skin contact: Corrosive. May cause permanent damage. Harmful if absorbed through skin .

Inhalation: May cause irritation and corrosive effects to nose, throat and respiratory tract.

Ingestion: Corrosive. May cause burns to mouth, throat and stomach .

4. FIRST AID MEASURES

Eye contact: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes. Call a poison control center or doctor for treatment advice.

Skin contact: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes . Call a poison control center or doctor for treatment advice.

Inhalation: If breathing is affected, remove to fresh air. If person is not breathing, call 911 or an ambulance and then give artificial respiration, preferably by mouth to mouth, if possible. Call a poison control center or doctor for treatment advice.

Ingestion: Call medical attendant, doctor, or poison control center immediately. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Never give anything by mouth to an unconscious person. Get medical attention immediately. Probable mucosal damage may contraindicate the use of gastric lavage.

Notes to physician: Individuals with chronic respiratory disorders such as asthma, chronic bronchitis, emphysema, etc., may be more susceptible to irritating effects

5. FIRE-FIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES

Personal precautions: Put on appropriate personal protective equipment (see Section 8.).

Environmental precautions and clean-up methods: Material is toxic to fish. Do not discharge into lakes, streams, ponds, or public water unless in accordance with an NPDES permit. 7. HANDLING AND STORAGE

Remove and wash contaminated clothing and footwear before re-use. Wash thoroughly after handling. Product residue may remain on/in empty containers. All precautions for handling the product must be used in handling the empty container and residue. FOR COMMERCIAL AND INDUSTRIAL USE ONLY.

Storage: Keep tightly closed in a dry, cool and well-ventilated place. Protect from freezing. Store in a cool, dry, well ventilated area away from heat or open flame. Keep out of the reach of children.

8. EXPOSURE CONTROLS / PERSONAL PROTECTION

Engineering measures to reduce exposure: Good general ventilation should be sufficient to control airborne levels Respiratory protection is not required if good ventilation is maintained.
