# 2. HAZARDS IDENTIFICATION

### **EMERGENCY OVERVIEW**

# **4. FIRST AID MEASURES**

Skin contact: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes . Call a

poison control center or doctor for treatment advice.

Inhalation: If breathing is affected, remove to fresh air. If person is not breathing, call 911 or an ambulance and

then give artificial respiration, preferably by mouth to mouth, if possible. Call a poison control center or

doctor for treatment advice.

Ingestion: Call medical attendant, doctor, or poison control center immediately. Have person sip a glass of water

if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor.

Never give anything by mouth to an unconscious person. Get medical attention immediately.

Notes to physician: Probable mucosal damage may contraindicate the use of gastric lavage.

Aggravated Medical Conditions: Individuals with chronic respiratory disorders such as asthma, chronic bronchitis, emphysema, etc.,

may be more susceptible to irritating effects
